Matters arising from those minutes

09/19 Minute 294/18 School Lane/Nethergate Street parking restrictions

The 'Keep Clear' markings are making that corner safer but the cars are now parking further up the road on the opposite side. This is forming a chicane in the road but actually slowing the traffic. There has not been any problem with parking on School Lane and so the sign is to be shelved.

010/19 Minute 295/18 Brick Yard Lane

Thanks extended to Cllr Campbell for the posts which now need capping, painting white and reflectors adding. The posts are keeping people off the grass verge.

011/19 Positioning of the seat originally on the footpath along field edge.

Cllr Steed will help Cllr Cable with this. It was suggested that by siting the seat further down the path the view will be lost. There was some concern about the safety of the railings in the original position but it was felt that this could be sorted out. Cllr Steed will liaise with Cllr Cable.

012/19 Footpaths

It is still a little wet from the silo area to the main road. Hardcore has helped along to the top of Tinklers Drove. Signs at the top of Tinklers Drove and on Millers Lane have fallen over. Highways to be contacted. Cllr Richards will trim the hedge on the path from Millers Lane.

013/19 Brick Yard Lane Nature Reserve

The Community Rehabilitation Service working groups have made a start on the clearance of undergrowth to make rough paths around the top of the pits. The next stage will be to clear routes into the pits. Next working group will be 7th February then weekly until 28th March.
