Progress is being made. Highways have filled some potholes in the roadway and surfaced the pavement.

296/18 Minute 278/18 White Village Entrance Gates

The possibility of upgrading the 30mph speed limit sign on Mill Road to one which incorporates the village name was discussed. The total cost for two signs would be £672 so, if a grant could be obtained from the Parish Partnership Scheme, the parish council would have to contribute £336. Cllr M Chenery of Horsbrugh kindly offered to contribute this amount from his Local Members' Fund. It was proposed by Cllr Cable that the parish council should apply for Parish Partnership funding for the road signs. All present agreed.

297/18 Positioning of the seat originally on the footpath along field edge.

The seat needs to be secured to a concrete base. It was decided that it should be placed near to the Short Lane end of the path away from the fence spikes just beyond the bungalow. Cllr Cable will action.
